

Your privacy is a top priority at My Tamil Song.com , (“My Tamil Song.com”). Please read our Privacy Policy details.

My Tamil Song.com will use the information that we collect about you to facilitate your downloads and personalize your online experience.

Except as otherwise discussed in this Privacy Policy (“Policy”), this document only addresses the use and disclosure of information collected from you online. For some services, we either collect and transfer personal information to a service provider you have selected, or you may visit other merchants through links on our site who may collect and use your personal information. In that case the third-party service provider or merchant's privacy policy will govern how your information is handled. If you visit any other site available through a link on our site, they will independently collect, use and share your personal information in accordance with their privacy policies. Please carefully read their privacy policies before browsing their site. Unless you are on My Tamil Song's web site, any time that you have moved to a window, you should assume that your personal information is being collected, used and disclosed in accordance with the windowed site's privacy policy (if any).

My Tamil Song.com collects personal information and non-personal information.

Personal information refers to information that lets us know the specifics of who you are. Personal information is requested when you set up a customer account (“My Account”), order a download and send us feedback. This information may include your name, billing address, telephone number, e-mail address, credit card or other payment information and download details. My Tamil Song.com uses this information to fill your orders and better provide you with personalized services.

Non-personal information refers to information that does not by itself identify you. We may gather certain information about you based upon where you shop on our site in several ways. This information may be compiled and analyzed on both a personal and an aggregated basis. By way of example, non-personal information may include the website's Uniform Resource Locator ("URL") that you just came from, which URL you next go to, what browser you are using, and your Internet Protocol ("IP") address.

My Tamil Song.com gathers information when you set up a Customer Account. Before you may order Digital Downloads or make other purchases, you must first establish a customer account. To set up a Customer Account, we will collect your name, and a password established by you and an e-mail address. We may use that information to set up a personal greeting that you will see when you return to our site and to contact you. We may also track your traffic patterns throughout your online session, including the pages, information and advertisements you view while using the site and what music you download. Your IP address may be used by us to diagnose problems with our servers, software, administer our site and gather demographic information.

We will collect personal information from you when you order a music download from us. We collect and maintain your name, e-mail address, billing and shipping address, shipping contact telephone numbers, music selections, credit card or other payment information and a password. This information is collected as disclosed in this Policy, in order to download the music to you, to pay music royalties, and to administer our site. We will not disclose your personal information to any intellectual property rights-holders without your prior consent. We may, however, make our customer records available to record labels outside auditing agents on a confidential basis as part of periodic audits of our download sales.

We offer free promotional e-mails as a service to our customers. We will send you e-mails periodically listing current specials and deals if you have opted-in to receive promotional emails at signup. We will not send you any e-mails in the future, unless you make another purchase.

If you contact My Tamil Song.com or our customer service representatives by telephone, e-mail or letter, we may keep a record of your correspondence or comments. If you report a problem with our site, we may collect such information in a file specific to you. If you contact us by e-mailing one of our customer service representatives, we may ask for your name, and verifying order information in order to send you a reply. If other users or third parties send us correspondence about your activities or purchases on our site, we may keep the information in a file specific to you.

We may display advertisements on our site. By knowing a little about you, My Tamil Song.com will be able to deliver more relevant advertisements and content to you in the form of targeted banners and promotions. We may also have third-party advertising servers display ads linked to certain search terms that you have entered, artists, or to certain pages that you are viewing. Advertisers never have access to individual account information.

When you use our site we will store cookies on your computer in order to facilitate and customize your use of our site. A cookie is a small data text file, which a Web site stores on your computer's hard drive (if your Web browser permits) that can later be retrieved to identify you to My Tamil Song.com. Our cookies store randomly

assigned user identification numbers, the country where you are located, and your first name to welcome you back to our site. The cookies make your use of the site easier, allow you to retrieve an earlier shopping cart, make the site run more smoothly and help us to maintain a secure site. You will be unable to shop on our site without your browser set to accept cookies. We may use an outside ad serving company or content server to display banner advertisements and other information on our site or to serve promotional emails. As part of their service, they place a separate cookie on your computer. My Tamil Song.com does not provide third-party ad servers with any of your Personally Identifiable information.

You may set your browser so that it will not accept "cookies" to prevent assignment from the ad server of a unique identifier; however, you will be unable to shop on our site if you do so.

We may use third party ad servers or content servers to serve ads, product information, or other information both on and off our site. Those third parties may use "action tags" or web beacons throughout the site to count the number of visitors who click on a banner ad or other information and to track the number of customers who continue on to make a purchase. They may also place their own "cookie" on your computer to help those ads to run and analyze site usage. We do not provide them with any of your personal information.

When you download music, the information collected by My Tamil Song.com is used for downloads, reporting those downloads to record labels and aggregated basis for statistical purposes, for improving our site and its performance, to serve ads, and to notify you of products or special offers that may be of interest to you. We will disclose your personal information to third parties to charge your credit card and deliver promotional e-mails to you from My Tamil Song.com.

Where you sign up for music or other products offered through our site, but sold directly to you by a third party, we give your personal information to that third party (e.g., a music CD available on our site from a sponsoring third party).

Occasionally My Tamil Song.com may be asked by law enforcement or judicial authorities to provide personal information to the appropriate governmental authorities. We will disclose personal information upon receipt of a court order, subpoena, or to cooperate with a law enforcement investigation, without prior notice to you. My Tamil Song.com fully cooperates with law enforcement agencies in identifying those who use our services for illegal activities. We reserve the right to report to law enforcement agencies any activities that we believe to be unlawful.

You may edit the personal information that you provide to us. You can review, change, or delete the information that you have submitted. You may change any of your personal information in your customer account online at any time. We expect

you to promptly update your information if it changes. You may ask to have the information on your account deleted or removed but you cannot delete information associated with past purchases. As a security measure, the data stored on our systems is “backed up,” and such prior information cannot effectively be removed from our databases. Accordingly, you should not expect that all of your personal information will be completely removed from our backed-up databases.

Established third party banking and processing agents handle all credit card transactions. They receive the information needed to verify and authorize your credit card or other payment information.

Your account information is kept on a secure server. All of the customer data we collect when you place an order is protected against unauthorized access by advanced encryption and firewall technology. To further ensure your security, we use state-of-the-art Secure Sockets Layer (“SSL”) encryption to protect your personal information from unauthorized use.

You must be at least 18 years old to have our permission to use this site. We do not knowingly collect, use or disclose personal information about visitors under 18 years of age. If you are the parent or guardian of a minor under 18 years of age and believe that we have collected the minor's personal information, please contact us at

privacy@mytamilsong.com so that we may delete their information from our current records.

Our third-party ad servers may occasionally use outside agents, whose computers will serve ads on our site in the same manner and under the same conditions as above. In addition, other ad serving companies or advertisers may place banner ads on our site in the same manner as above, but we do not disclose to them any personal information.
